COMPETITION TERMS & CONDITIONS

Event: 2025 Bathurst 1000

- **Competition Dates:**

Open Date: 12.00pm (Midday) AEDT Tuesday, 7 October 2025.

Close Date: 12.00am (Midnight) AEDT Sunday, 12 October 2025.

- **Competition Prize:** The winner (**one only**) will receive a Supercheap Auto voucher/s to the value of AU\$1000 (Australian Residents) or NZ\$1000 (New Zealand Residents).
- **Eligibility:** Entry is only open to Australian and New Zealand Residents. All entrants must be 18 years of age, or older. **Accredited media:** Accredited event media are not eligible to partake in the competition.
- **How to Enter:** The entrant must complete the following steps during the competition date period listed above:
 - a) Visit the Speedcafe Photo Competition Facebook page.
 - b) In the comments post a photo, or photos, as per the **Entry Image Requirements & Suitability** below.
- **Entry Image Requirements:**
 - a) Images must be of the 2025 Bathurst 1000 Supercheap Auto Wildcard #888 Racing Car, the 2025 Supercheap Auto drivers (Craig Lowndes, Zach Bates) wearing Supercheap apparel or race suit, or the 2025 Supercheap Auto garage at the event.
 - b) Images can be taken with any equipment that meets the conditions of entry to the event. (See Supercars website for conditions of entry details.)
 - c) All images are to be taken between October 7 & October 12, at official appearances and trackside during the event.
- **Suitability:**
 - a) All entries must adhere to social media guidelines and be relevant to the event and image requirements.
 - b) Images must not be watermarked.
 - c) Only still photos are suitable – video will not be approved for entry in the competition.
- **Number of Entries:** There is no limit to how many images can be submitted per participant. Images can be uploaded at any point of time over the duration of the event and up to the deadline as below.
- **Originality:** All entries must be original work and must not infringe upon the copyrights or intellectual property rights of any other individual or entity and must not breach the conditions of entry to the event.

- **Consent:** Images submitted may be utilised on the <http://Speedcafe.com> website, or Speedcafe social media, without the consent of the entrants. Any images used for an editorial story on the <http://speedcafe.com> website will be credited to the competition entrant/photographer as listed on their photo comment.
- **Deadline:** Images posted after 10.00pm AEST on Sunday 12 October 2025 will not be eligible for the competition.
- **Judging:** The winner will be determined by a Speedcafe, Media Accredited, Photographer and a member of the Supercheap Auto Management Team acting as the photo competition judges. The best valid entry, as determined by the judges, will win the prize as specified above. The winner will be determined on the merits of the photographs entered.  - a) The winner must reply, to Speedcafe, via Direct Message within seven (7) days of being notified, as above.
 - b) The AU\$1000 or NZ\$1000 Supercheap Auto Voucher will be sent electronically to the winner.
